Investment objective

The Fund's investment objective is to seek long-term growth of capital and income.

The Fund invests primarily in common stocks of companies in developed countries outside the United States. Normally, the Fund invests at least 80% of its total assets in stocks of companies in a number of foreign countries, and invests the majority of its total assets in companies that pay dividends or repurchase their shares.

Market commentary

Heightened geopolitical tensions and concerns of a broader slowdown in global economic growth pressured equity markets in the fourth quarter. The top performing markets in our investable universe were Turkey, Hong Kong, New Zealand, Singapore, and Spain. The worst performing markets were Austria, Belgium, Norway, Ireland, and Germany. The best performing sectors in the MSCI EAFE Index ("Index") were utilities, real estate, and communication services. The worst performing sectors were energy, information technology, and materials.

The Causeway International Value Fund ("Fund") underperformed the Index during the quarter, due primarily to stock selection. Attractive valuations did not provide immunity from the selling, especially in non-US equity markets. Fund holdings in the insurance, food beverage & tobacco, energy, banks, and media & entertainment industry groups detracted from relative performance. Holdings in the materials, automobiles & components, pharmaceuticals & biotechnology, and consumer durables & apparel industry groups, as well as an overweight position in the telecommunication services industry group, offset some of the underperformance. The largest detractor was oil & natural gas producer, Encana (Canada). Additional notable detractors included British American Tobacco plc (United Kingdom), banking & financial services company, UniCredit S.p.A. (Italy), internet services provider, Baidu (China), and life insurer, Prudential Plc (United Kingdom). The top contributor to return was industrial gas company, Linde Plc (Germany). Other notable contributors included retail & commercial bank, Akbank TAS (Turkey), pharmaceuticals & biotechnology company, Roche Holding AG (Switzerland), alcoholic beverage distributor, Diageo Plc (United Kingdom), and multinational electric utility company, ENGIE SA (France).
