## Investment objective

The Fund's investment objective is to seek long-term growth of capital and income.

The Fund invests primarily in common stocks of companies in developed countries outside the United States. Normally, the Fund invests at least 80% of its total assets in stocks of companies in a number of foreign countries, and invests the majority of its total assets in companies that pay dividends or repurchase their shares.

**Market commentary**

Increasingly dovish commentary from the US Federal Reserve and the European Central Bank, along with progress on US-China trade negotiations, supported equity markets in the first quarter of 2019. The top performing markets in our investable universe were China, New Zealand, Belgium, Canada, and Hong Kong. The worst performing markets were Turkey, South Korea, Singapore, Japan, and Germany. The best performing sectors in the MSCI EAFE Index ("Index") were information technology, real estate, and materials. The worst performing sectors were communication services, financials, and consumer discretionary.

The Causeway International Value Fund ("Fund") outperformed the Index during the quarter, due primarily to stock selection. Fund holdings in the pharmaceuticals & biotechnology, software & services, banks, insurance, and food beverage & tobacco industry groups contributed to relative performance. Holdings in the telecommunication services, capital goods, automobiles & components, and materials industry groups, along with an underweight position in the real estate industry group, offset some of the outperformance. The top contributor to return was British American Tobacco plc (United Kingdom). Other notable contributors included Takeda Pharmaceutical Co., Ltd. (Japan), enterprise infrastructure software company, Micro Focus International Plc (United Kingdom), global life insurer, Manulife Financial (Canada), and life insurer, Prudential Plc (United Kingdom). The largest detractor was wireless communications operator, SK Telecom Co., Ltd. (South Korea). Additional notable detractors included telecommunication services provider, KDDI Corp. (Japan), retail bank, Caixabank SA (Spain), telecommunication services provider, Vodafone Group (United Kingdom), and integrated oil & gas company, Total (France).
