Normally, the Fund invests at least 80% of its total assets in stocks of companies in a number of foreign countries, and invests the majority of its total assets in companies that pay dividends or repurchase their shares.

**Market commentary**

Equity markets fluctuated in the second quarter as tensions between the US and its major trading partners - including China and Europe - escalated, posing an increasing threat to global economic growth. The percentage of stocks in bear market territory is also rising sharply, with over 22% of the MSCI World Index constituents now down more than 20% from their peak; this percentage has more than tripled since the end of January, 2018. The top performing markets in our investable universe included Israel, New Zealand, Australia, Canada, and Norway. The worst performing markets included Austria, South Korea, Singapore, Denmark, and Italy. The best performing sectors in the MSCI EAFE Index ("Index") were energy, health care, and materials. The worst performing sectors were financials, telecommunication services, and consumer discretionary. Currency proved a headwind as major currencies declined against the US dollar.

The Causeway International Value Fund ("Fund") underperformed the Index during the quarter, due primarily to stock selection. Fund holdings in the food beverage & tobacco, pharmaceuticals & biotechnology, banks, consumer durables & apparel, and consumer services industry groups detracted from relative performance. Holdings in the energy, software & services, materials, capital goods, and telecommunication services industry groups offset some of the underperformance. The largest detractor was automobile manufacturer, Volkswagen AG (Germany). Additional notable detractors included banking & financial services company, UniCredit S.p.A. (Italy), banking & financial services company, Barclays Plc (United Kingdom), British American Tobacco plc (United Kingdom), and Takeda Pharmaceutical Co., Ltd. (Japan). The top contributor to return was industrial gas company, Linde AG (Germany). Other notable contributors included crude oil & natural gas company, BP Plc (United Kingdom), oil & natural gas producer, Encana (Canada), energy supermajor, Royal Dutch Shell Plc (United Kingdom), and business software & services provider, SAP SE (Germany).
